



## Bypass roads, bridge projects launched

Tiruvannamalai, Feb 12: Public Works, Highways and Minor Ports Minister E.V. Velu on Wednesday inaugurated and laid foundation stones for multiple road infrastructure projects in Chengam taluk, including bypass roads and a high-level bridge, at an event held in Mannalai panchayat.

The projects include a Rs 34 crore bypass road for Chengam town, a Rs 45 crore bypass road in Thandampattu, and a Rs 11 crore bypass road

for Keezhsiruppakkam/Melchiruppakkam. A high-level bridge built at a cost of Rs 7 crore connecting Thokkavadi and Keelapalli across the Cheyyar river was also inaugurated.

The minister said that several low-level bridges in rural areas are being upgraded to high-level bridges based on requirements. Over the past four-and-a-half years, development works worth Rs 395 crore have been completed in Chengam constituency, including road upgrades

and construction of small bridges. About 82 km of panchayat union roads have been upgraded into two-lane roads at a cost of Rs 90 crore, and 18 low-level and high-level bridges have been built at a cost of Rs 22 crore.

An allocation of Rs 43 crore has also been made for the Nandan Canal project, which is expected to benefit residents of Chengam, Tiruvannamalai, Keelpennathur and adjoining Vikravandi constituencies once completed.
